4. Final materials submitted (results, forms, fees, etc.) within 21 days of the conclusion of my event.
5. Payment of all monies collected on behalf of the ATRA within 21 days of the conclusion of my event.
6. Regular reports /updates including materials that I have collected if my event lasts for a period of weeks or months such as club ropings or saddle series events.

Contract Guidelines

I realise that any failure on my part to meet all outlined requirements in this contract/application may result in the loss of or increase in a deposit, suspension of a producer/organiser, assistant producer and/or event from being able to sanction through the ATRA in the future at the discretion of the ATRA. The ATRA reserves the right to deny event sanctioning to any organizer/event for any reason.
